Relevant Articles in Statutes

Article 10 Executive Board

- The Committee shall elect an Executive Board consisting of: The President, Three Vice Presidents, and Other Members (up to nine).
- The term of the Executive Board shall be **three years**. The President, Vice Presidents and Executive Board Members shall be **elected every three years** at the triennial plenary meeting of the Committee. The President and Vice Presidents may be reelected, but **shall not serve more than two consecutive terms** in that office.
- Each Working Group shall, where possible, be chaired by a member of the Executive Board, but if this is not the case then Chairs of Working Groups will be ex-officio members of the Executive Board and become an addition to the defined Executive Board positions.

Relevant Articles in Statutes

Article 11 Functions of Executive Board

- Plan and coordinate the Committee work program between plenary sessions of the Committee;
- Plan and manage the activities that the Committee undertakes for the UN-GGIM in consultation with the United Nations;
- Make recommendations on objectives, activities and work programs to the Committee;
- Coordinate funding proposals to aid agencies;
- Represent the interests of the Asia and Pacific region in the world's geospatial information management community;
- Take opportunities to give presentations to related bodies at conferences and other relevant events;
 - **Examine and approve all the meetings** organized or sponsored in the name of the Committee.

Rule of Procedure on election

Rule 19

 All elections shall be held by secret ballot, unless otherwise decided by the Committee.

Rule 20

 In the case when one person or one delegation is to be elected and no candidate obtained the required majority in the first ballot, a second ballot shall be taken, which shall be restricted to the two candidates obtaining the largest number of votes in the first ballot.

Rule 21

 In the case when a vote is equally divided on matters other than elections, a second vote shall be taken. If this vote is also equally divided, the proposal shall be regarded as rejected.

Next steps

- 1. The Secretariat, under instructions from the President, shall provide Members, Advisors, and Observers with a written notice regarding the date, venue, and the agenda for the 14th Plenary meeting of the UN-GGIM-AP, by 1 July 2025.
- 2. By 5 July 2025, the President will send a letter to ALL member countries of the AP Committee to request them to consider the election of EB and informally express their interest in being the EB members, President and Vice-President. The feedback from member countries should be sent to the Secretariat by 30 July 2025.
- 3. The Secretariat will report to the President the feedback from the member countries by 10 August.

UN-GGIM-AP EB members



- 1. A letter to ALL member countries on their interest in being the EB members, President and Vice-President, should be sent to current focal points of the UN-GGIM-AP in a country and copy the Seat of Government (MoFA).
- 2. If the current EB members wish to continue for the 2nd term of the membership till 2028, how to process?
- 3. If the nominations for the Executive Board consisting of the President, three Vice Presidents, and other Members are less than NINE, the 14th Plenary meeting announces the nominations.
- 4. In case the nominations are more than NINE; a secret ballot will be conducted at the 14th Plenary meeting.
- 5. In case more nominations for the President and VPs are given by member countries, should the current President discuss this with the nominations

Article 13 Working Groups

- Working Groups may be established, with the approval of the Committee, to carry out the objectives of the Committee.
- Working Groups may initiate and terminate projects in areas of concern to the Committee.
- Working Groups shall report regularly to the Committee on their activities, together with recommendations for consideration by the Committee.
- Each Working Group shall, where possible, be chaired by a Member of the Executive Board, but in the case of a Working Group Chair not being a Board Member then he/she will be an ex-officio member of the Board.



- Working Group Chairs are able to appoint coordinators for key activities within their work program and these coordinators may report to the Working Group Chairs.
- In so far as they are applicable, the Rules of Procedures set forth from the Committee shall also apply to the procedures of the working groups.

Article 15 Occurrence of Meetings

 At every third plenary meeting of the Committee, the Executive Board shall report on the activities over the last three-year term; the existing Working Groups shall be renewed or concluded.



- 1. UN-GGIM-AP will decide whether the current WGs continue or new WGs are established during the 14th Plenary meeting of UN-GGIM-AP in 2025.
- 2. In accordance with the resolution approved in the 13th Plenary meeting of UN-GGIM-AP in 2024, some working groups including the Virtual Technical Advisory Group for the Pacific, the Young Geospatial Leaders Network and Al Working Group can be considered.
