**Objective 3:****Support and assistance in the production of Cadastre and Land Management Framework, overarching policy guidance on land administration and management, working with UN-GGIM Expert Group on Land Administration and Cadastre**

**Goal:** Enhance understanding of overarching policy guidance for sustainable and interoperable land administration and management systems from existing global concepts, approaches, and national geospatial information management systems referencing to global guidelines working with EG on Land Administration and Cadastre

- **Deliverables:**

- **Year 1:** Share information on global guidelines with member countries
- Work in close collaboration with EG on Land Administration and Cadastre to provide input on the Cadastre and Land Management Framework to reflect the region.
- **Year 2:** Review work by EG above and other organizations to reflect views of the region
- **Year 3:** Continue work with EG for the finalization of Framework

- **Method:**

- Coordinate and work closely with members and also with chairs of the EG on Land Administration and Cadastre

**Objective 4:****Support and assistance in the production of Integrated Geospatial Information Framework, overarching policy guidance on geospatial information for the UNGGIM**

**Goal:** Enhance understanding of overarching policy guidance for sustainable and interoperable land administration and management systems from existing global concepts, approaches, and national geospatial information management systems referencing to global guidelines, especially the Integrated Geospatial Information Framework

- **Deliverables:**

- **Year 1:** Share information on global guidelines with member countries
- Work in close collaboration with EG on Land Administration to provide input on the Cadastre and Land Management Framework but also the Integrated Geospatial Information Framework to reflect the region.
- **Year 2:** Review work by EG above and other organization to reflect views of the region in the framework production
- **Year 3:** Continue work with EG for the finalization of framework

- **Method:**

- Coordinate and work closely with members and chairs of the EG on Land Administration and Cadastre
- Work closely with the WB, contributing to the UN Integrated Geospatial Information Framework to reflect the position and views of the region.

### **Objective 5:**

#### **Development of capacity building plan and training at the regional level**

**Goal:** Enhance the human capacity in areas related to land administration/ management and cadaster including data collection, systems, institutional or legal framework, and other pertinent sectors.

▪ **Deliverables:**

- **Year 1:** Introduction of tools for diagnosis and assessment of land sector to develop a capacity model for countries in region with land challenges
- **Year 2:** Selection and execution of tool in a particular country
- **Year 3:** Report on the outcome of the activities

▪ **Method:**

- Conduct research on different capacity building tools used globally in the land sector, especially tool within the UNGGIM Framework
- Coordinate with members to select country to carry out the diagnosis and assessment
- Work with focused country to produce outcome of the activities
